

## FLORIDA DAIRY FARMERS SPLASH INTO SUMMER WITH MILK SWEEPSTAKES OFFICIAL RULES

PLEASE REVIEW THE “DISPUTES” PARAGRAPH IN THESE OFFICIAL RULES REGARDING YOUR RIGHTS IN ANY DISPUTE INVOLVING THIS PROMOTION, INCLUDING A MANDATORY ARBITRATION CLAUSE OR WAIVER OF A JURY TRIAL OR CLASS ACTION, THAT LIMITS YOUR RELIEF.

1. The Florida Dairy Farmers ‘Splash into Summer with Milk’ Sweepstakes (the “Promotion”) is sponsored by Florida Dairy Farmers, 1003 Orienta Ave., Altamonte Springs, Florida (“Sponsor”). Promotion is only offered to residents of the state of Florida (the “Promotion Area”). Promotion is void outside the Promotion Area and where prohibited by law.

38. THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN FLORIDA.
